We invite you to participate in our healthmonitoring and navigation service. A MATCH clinician will call you periodically to offer various supports, including, but not limited to:

- Connecting you to community resources
- Providing emotional telephone support
- Assessing for hospice, palliative, or skilled home health eligibility.

We welcome the opportunity to partner with you to address your needs and goals.

WHO IS ELIGIBLE FOR THE PROGRAM?

Patients who have received services from By the Bay Health (Hospice, Palliative, Home Health, or Pediatric programs) or those who are interested in our services, and other members of the community who could benefit from this program.

WHO PAYS FOR THIS SERVICE?

There is no charge to clients in the MATCH program. By The Bay Health provides this service through our fund of charitable contributions.

ROLE OF THE PRIMARY CARE PROVIDER

All medical needs (including wound care and medication management) will continue to be provided by your Primary Care Provider. For emergent or critical care needs, clients or their families should contact the Primary Care Provider or a local hospital.



WHAT WILL THE MATCH TEAM ASSESS?

A MATCH clinician may notify your Care Provider when there are changes with your health that may qualify you for one of our Home Care Services. The MATCH clinician may also assess for additional supportive community resources.
